

Pomona Thomas Plaza Farmers Market on 2nd St.

(Located in Thomas Plaza in Downtown Pomona at W. Second St. and Thomas St.)

The market will be held every Wednesday as well as every 2nd and last Saturday of the month from 4pm to 8pm. The fee is \$15 for each market evening. Vendors must bring their own canopy/booth (approx. 10x10), table, chairs, lights and extension cord. Vendors can start setting up two hours before the start of the market. There will be a portable restroom and sink on site. Before being permitted to sell at the market, all food vendors must have a valid L.A. County Health Permit for this location and a one million dollar liability insurance policy naming the DPOA, their agents, officers, volunteers, and the City of Pomona and their agents, as additionally insured.

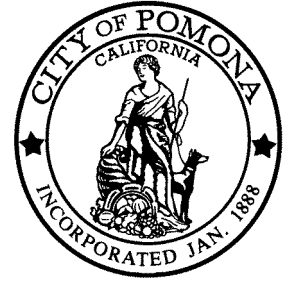
